



## ISSCR Speaker Agreement

**Thank you for participating in an ISSCR event. Your contributions make it possible for the ISSCR to develop exceptional scientific programs for the global stem cell research community.**

**Please review the following speaker policies and permissions and affirm your understanding and agreement of the terms.**

### **ISSCR Research Conduct Policy**

The agreement to speak at an ISSCR event constitutes a formal agreement that the speaker has conducted the reported research in accordance with relevant institutional and national guidelines, regulations regarding experiments on human subjects, live vertebrates or higher invertebrates, and the [ISSCR Guidelines for Stem Cell Research and Clinical Translation](#).

### **ISSCR Research Communication Policy**

The ISSCR is committed to ensuring that the public presentation of stem cell research and its applications are done responsibly to avoid misrepresentation of the work and misleading of the public (see Recommendation 4.1, [ISSCR Guidelines for Stem Cell Research and Clinical Trials](#)). This is especially important for sensitive areas of research including chimeras, embryo models, and some brain organoid work. For example, [the ISSCR advises against](#) using the term “synthetic embryo” to describe stem cell-based embryo models. Such embryo models should also be described as integrated or non-integrated to ensure precise communication. To ensure that the science presented at ISSCR meetings is accurately represented, we may ask speakers to revise the language used in their titles, abstracts or presentations.

### **Permission for Use of Name and Likeness**

Speaker gives the ISSCR, its agents and representatives the right to use their name and likeness in promotional and other material published in relation to ISSCR meetings and programs.

### **Conflict of Interest Disclosure Policy**

Speaker agrees to disclose any financial, intellectual, or other relationships with commercial interests that constitute a potential or real conflict of interest (COI) to ISSCR. This information must be disclosed to attendees verbally and/or on a slide at the beginning of each presentation whether or not a COI exists.

### **Permission for Publication, Recording and Use of Material**

- Speaker grants the ISSCR copyright to use video recordings of the speaker’s presentation for inclusion in the proceedings for the conference in which they

are speaking. Speaker grants the ISSCR a right to rebroadcast or otherwise use the recording for 12 months following the meeting.
